Develop and implement Individual Education Programs for students who qualify for speech and/or language services, according to the Idaho Manual for Special Education, which may include direct individual or group therapy in person and/or virtually (no more than 2 students per group), in person and/or virtual consulting, and/or in person or virtual monitoring of progress.
 - c. Consult and coordinate with appropriate personnel about student services and needs.
 - d. Make recommendations regarding service delivery and the students' need to the IEP team for team consensus.
 - e. Provider will attend meetings, in person and/or virtually, such as IEP meetings and conferences, when scheduled on regularly scheduled speech and language therapy service day.
